A motion was made by Mr. McCullough to approve the minutes from April 11, 2022 Supervisors Meeting. Seconded by Mr. Burkett. Motion passed with 3 yes votes.

Motion was made by Mr. McCullough and seconded by Mr. Angermeier to pay the following payables for April 11, 2022 through May 9, 2022. Motion passed with 3 yes votes.

A motion was made by Mr. Burkett to approve the following additions and exonerations for April 2022 tax duplicate of Real Estate 1 \$10.15 and Real Estate Exons 1 \$35.70. Seconded by Mr. McCullough. Motion passed with 3 yes votes.

Mr. McCullough announce the bridge project for 2023 on Valley Road.

A motion was made by Mr. McCullough to approve the seal coat bids for Seidle Road. Russell Standard was awarded the bid. 18,272 SY Asphalt Surface Treatment - Modified \$5,670 total \$103,602.24. Will consist of the placement of MC-70 & No. 67 Limestone, then followed with a conventional double seal coat. Seconded by Mr. Angermeier. Motion passed with 3 yes votes.

A motion was made by Mr. McCullough to approve Mr. Burkett to be on the Superior Ambulance Task Force. Seconded by Mr. Angermeier. Motion approved with 3 yes votes.
