The monthly meeting of the Jefferson Township Board of Supervisors was called to order by Mr. McCullough on February 13, 2023, at 7:03pm at the Jefferson Township Building, 7407 Lamor Rd, Mercer, PA 16137.

The Pledge of Allegiance was recited and Roll Call was taken at the reorganization meeting ahead of regular meeting. In attendance were Supervisors John Burkett, Richard McCullough, & Tyler Angermeier and Secretary/Treasurer Rachel Nickel, along with the public sign in sheet.

A motion was made by Mr. McCullough to approve the reorganization minutes from January 3, 2023 Supervisors Meeting. Seconded by Mr. Angermeier. Motion passed with 3 yes votes.

A motion was made by Mr. McCullough to approve the minutes from January 3, 2023 Supervisors Meeting. Seconded by Mr. Angermeier. Motion passed with 3 yes votes.

Motion was made by Mr. Angermeier and seconded by Mr. McCullough to pay the following payables for January 3, 2023 through February 13, 2023. Motion passed with 3 yes votes.

A motion was made by Mr. Burkett to approve the reconciliations for December 2022 & January 2023. Seconded by Mr. Angermeier. Motion passed with 3 yes votes.

Mr. Grawl of Steister Road asked if township supervisors knew anything if the gas well pad was being taken out. And if Steister Road was going to be worked on.

Administrative Actions:

Mr. Burkett made a motion for Resolution ARPA 3 of 2023. Mr. McCullough seconded. Motion passed with 3 yes votes.

Mr. Burkett made a motion for Resolution 2023 Mercer County Joint Seal Coat Bid Program 4 of 2023. Seconded by Mr. McCullough. Motion passed with 3 yes votes.

Mr. Angermeier made a motion to accept the addition and exonerations for December 2022 Tax Duplicates of Per Capita 6 \$40 and Per Capita 5 \$50. Seconded by Mr. McCullough. Motion passed with 3 yes votes.

Mr. Angermeier made a motion for Resolution 2023 Tax Collection Committee Appointment 5 of 2023. Seconded by Mr. Burkett. Motion passed with 3 yes votes.

Mr. Burkett read all 10 sealed bids that came in for the township farm land that is up for lease. The awarded bid went to Mr. George Humes for \$101.00 for 19 acres of farm land. Payment will be annually with a signed contract between the township and Mr. Humes. Seconded by Mr. McCullough. Motion passed with 3 yes votes.

Mr. Burkett made a motion to approve the executive meeting January 27, 2023 on the proposed police union addendum to the contract. Seconded by Mr. McCullough. Motion passed with 3 yes votes.

Staff Reports:

- Police Department Chief Lockard gave his yearly report. Call volumes have gone up, lots of main roads in the township. Chief Lockard would like 2 more security cameras and a fob added to the police hall door.
- Fire Department Chief Lockard gave his yearly report.

- Road Report Mr. McCullough reported the roads he would like to have in the seal coat bid program. The F-750 truck should be back with in 2 weeks and be ready for plowing snow.

Mr. McCullough discussed the Lake Road Project and possible Kyle Road option. The township will bid out for a level and seal coat for .9 tenths of a mile.

Mr. Burkett read the dates for the upcoming meetings.
