A motion was made by Mr. McCullough to approve the minutes from October 9, 2023 Supervisors Meeting. Seconded by Mr. Angermeier. Motion passed with 3 yes votes.

A motion was made by Mr. McCullough to approve the minutes from the October 10, 2023 Budget Meeting. Seconded by Mr. Angermeier. Motion passed with 3 yes votes.

Motion was made by Mr. Angermeier and seconded by Mr. McCullough to pay the following payables for October 9, 2023 through November 13, 2023. Motion passed with 3 yes votes.

A motion was made by Mr. Burkett to accept the Resolution 4 of 2023 to apply for the LSA grant. Seconded by Mr. Angermeier. Passed with 3 yes votes.

A motion was made by Mr. McCullough to award the bid to Bobcat for an excavator. The township received bids from Bobcat, John Deere, Stephenson Equipment, Inc. The excavator will be purchased from Bobcat. E48 R2 series excavator for \$71,314.75 from Bobcat of Youngstown using sewer funds. Seconded by Mr. Angermeier. Passed with 3 yes votes.
